In the case of the above-named, the following action was ordered:

Deny mandatory parole and continue to expiration.

REASONS:

The Commissions finds that you have seriously violated the rules of the institution and that there is a likelihood that you will commit any Federal, State or local crime based on the following reasons: You have violated the rules of the institution on five occasions, one of which involved Use of Drugs on June 11, 1990. The remaining infractions involve abusing your telephone privileges on April 24, 2001 and again on May 9, 2007. You were also found guilty for contacting the public without authorization on May 9, 2007 and again for phone abuse on February 6, 2013, which involved you making a call to give a speech that was broadcast to a group of more than 200 people attending a symposium. Additionally, you take no responsibility for the crimes for which you were convicted. Information on your website, including your writings and in a recent letter you wrote to your supporters in 2014, indicates you routinely refer to yourself as a freedom fighter, a political prisoner, and the "victim" of the government's counter-intelligence program." Further, you end most of your writings with the salutation "Stiff Resistance," a phrase which is also prominent on your webpage. The Commission not only finds these statements incompatible with the goals and conditions of parole supervision, but also concludes they are evidence that you have not disavowed yourself from the same set of beliefs you had when you were convicted for your role as the leader in a Racketeering Conspiracy. The acts in furtherance of that conspiracy included members committing several armed robberies, murdering two armored car guards and two police officers as well as kidnapping (while armed) a prison guard and matron in the prison break of Joanne Chesimard (AKA: Assata Shakur) who was serving a life sentence for the murder of a New Jersey State Trooper, and who is still a fugitive from justice. All of these crimes were committed to further the aims of your criminal organization. The Commission finds that a combination of your recent written statements, your disciplinary infractions and your failure to accept responsibility for your crimes indicate that you have not rehabilitated and that there is a reasonable likelihood you will commit any Federal, State, or local crime.

You have also been scheduled for a statutory interim hearing during April 2018. At that time, your case will be reviewed again pursuant to 18 U.S.C. §4206(d).

The above is an Original Jurisdiction decision and is appealable to the Commission under 28 C.F.R. §2.27.

You may obtain appeal forms from your caseworker or supervising officer and they must be filed with the Commission within thirty days of the date this Notice was sent.

Copies of this Notice are sent to your institution and to your supervising officer. In certain cases, copies may also be sent to the sentencing court. You are responsible for advising any others you wish to notify.
