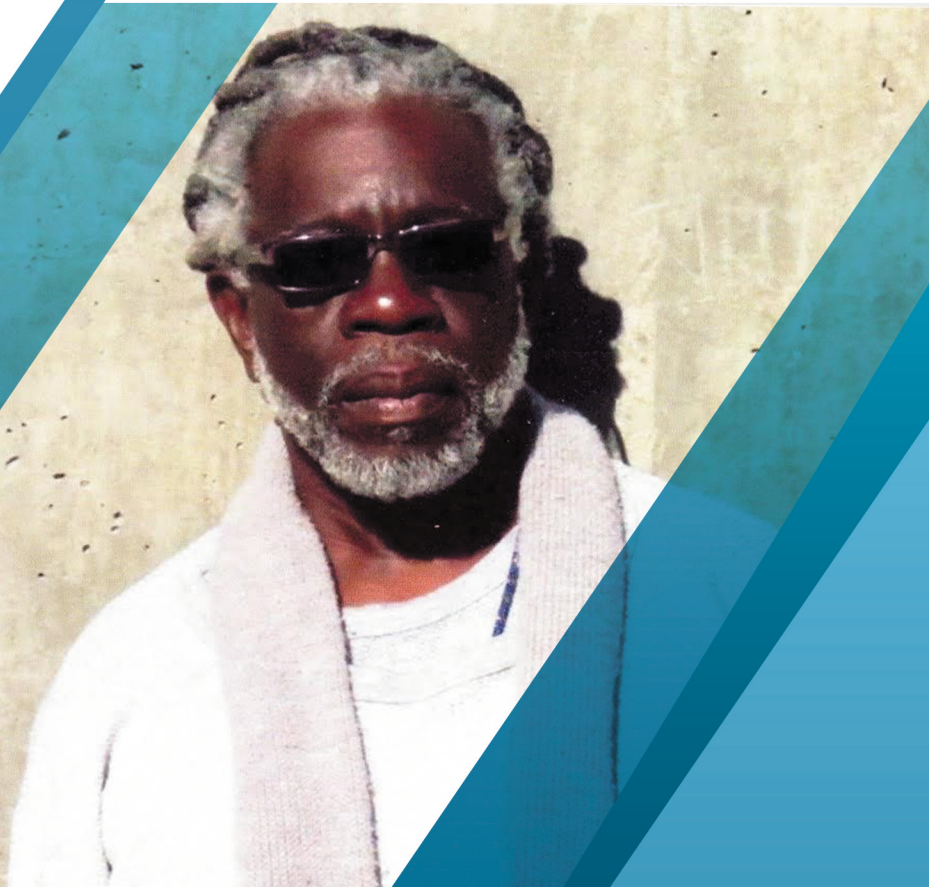

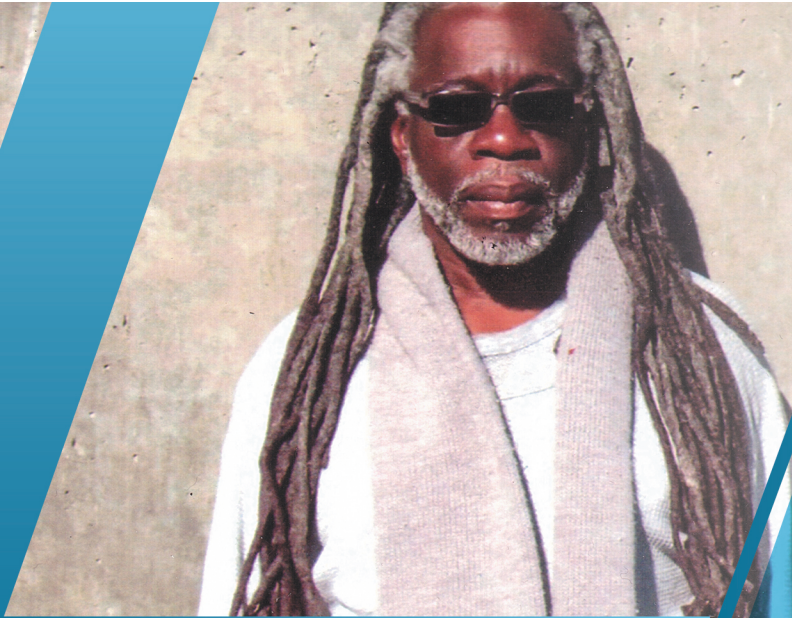


DR. MUTULU SHAKUR

Dr. Mutulu Shakur is a New Afrikan (Black) man whose primary work is in the area of health care.

Family & Friends of Dr. Mutulu Shakur is a collective of relatives, friends, supporters and political associates who have come together to support Mutulu's struggle for freedom. Dr. Shakur, a political prisoner incarcerated since 1986 in the federal prison system and a target of the FBI's Counterintelligence Program (COINTELPRO), was active in the Black Liberation Movement and worked tirelessly to improve the social, economic and political status of the disenfranchised in this country.

OUR PURPOSE

Our purpose is to obtain Mutulu's release from prison. We utilize all available resources spiritual, professional, political, educational and material in our work on his behalf.

WHO IS MUTULU SHAKUR

Dr. Mutulu Shakur is a doctor of acupuncture and is a co-founder of two institutions devoted to improving health care in the Black community. The Black Acupuncture Advisory Association of North America (BAANA) and the Harlem Institute of Acupuncture. He treated thousands of poor and elderly patients who would otherwise have no access to treatment of this type.

A New African Freedom Fighter

Since the age 16, Dr. Shakur has been a part of the New Afrikan Independence Movement. In 1970 Dr. Shakur was employed by the Lincoln Detox (detoxification) Community (addiction treatment) Program as a political education instructor. His role evolved to include counseling and treatment of withdrawal symptoms with acupuncture and eventually assistant director.

In March of 1982, Dr. Shakur and two others were indicted by a federal grand jury, charged with conspiracy and participation in a clandestine paramilitary unit that allegedly carried out actual and attempted expropriations from several banks. In addition he was charged with participation in the 1979 prison escape of Assata Shakur, who is now in exile in Cuba. After 5 years underground, Dr. Shakur was arrested on February 12, 1986. There was no physical evidence against him. He was convicted on the basis of the testimony of a former comrade who testified against him in exchange for a lighter sentence for himself and a cash payment from the government. Dr. Shakur is the father of six children. His son, Tupac, was killed in 1996.
